Agnes Taylor Rich Hoagland Schwartz (October 2, - December 11,) was a Mormon pioneer who played a key role in helping her brother, LDS Church president John Taylor, evade authorities during the federal crackdown on polygamy in the mids.

Laurice Bryant has raised serious concern about the unlawful arrest and imprisonment of Dr. According to Madam Bryant, throughout the process, Dr. Reeves Taylor was never cited as a person of interest or accused of committing any war crimes in the Truth and Reconciliation Commission TRC testimonies or its final report of submitted to and accepted by the Liberian government and the international community including the UK, nor has Liberia requested her arrest or extradition for any crimes. She disclosed that Dr. Reeves Taylor was arrested at her home in London on June 1, by the London Metropolitan Police, interrogated for two days consecutively, charged with alleged and unsubstantiated war crimes and kept in isolation for 12 days without any contact with her family based solely on accusations made by Civitas Maxima of Zurich, Switzerland through its subsidiary, Global Justice and Research Project headed by Hassan Bility covering She said best practice demands that evidence is gathered to substantiate an accusation before an arrest is made something that was ignored by the London Metropolitan Police acting on the authority of the Crown Prosecution Service CPS. Laurice said the London Metropolitan Police on their travel to Liberia after her arrest to find evidence to substantiate the allegations also overlooked exculpatory evidence and statements from people in Liberia, who were close to Dr. Reeves Taylor and worked with her in relief efforts during the period she is accused of committing the crimes. As an un-convicted prisoner, she ought to be treated as not guilty and adequately supported in conformity with the Prison Act Madam Reeves-Bryant clarified that Dr. Reeves Taylor was at no time a part of any military command during the Liberian Civil War, nor did she ever exert any command and control over the military wing of any warring faction or in a position of authority to command or control troops at any time. Reeves Taylor is not a British citizen but has been a resident of the UK for 20 years. She has never broken any UK laws.
