

Chapter 1 : Apply for a U.S. Visa | DS Information - India (English)

The DS, Online Nonimmigrant Visa Application form, is for temporary travel to the United States, and for K (fiancÃ©(e)) visas. Form DS is submitted electronically to the Department of State website via the Internet. Consular Officers use the information entered on the DS to process the.

The Form DS must be completed and submitted online prior to your interview at the Embassy or Consulate. The barcode number on the Form DS confirmation page is required in order to book your interview. The Form DS must be submitted online and the printed confirmation page must be brought to the interview. The Embassy or Consulate will not accept handwritten or typed applications and you will not be permitted to attend your interview without a Form DS confirmation page. When you sign your DS electronically, you are certifying that all the information contained in it is true and correct. Misrepresenting any facts could render you ineligible to enter the United States. Please double-check that all your answers are accurate and that every question is answered completely. Any inquiries on completing the DS will be addressed on the following website: We are unable to answer any questions or provide guidance on this process. You must submit your DS application online prior to making an appointment for an interview at the Embassy or Consulate. The interview post you select at the beginning of the Form DS must be the same post where you schedule your interview appointment. All questions must be answered in English using English-language characters only, except when you are asked to provide your full name in your native alphabet. If you stop working on this application for more than 20 minutes, your session will expire. You will have to start over, unless you have recorded your Application ID Number or have saved your application to a file on your computer. Write down the Application ID displayed on the top right-hand corner of the page. DS form will collect the necessary information from persons seeking a nonimmigrant visa to the U.S. Based on the information provided in the DS form and that combined with the personal interview, the consular officers will determine an applicant's eligibility for a nonimmigrant visa.

You should have the following documents available while you complete your DS Dates of your last five visits or trips to the United States, if you have previously travelled to the United States. You may also be asked for your international travel history for the past five years. Some applicants will need to have additional information and documents handy while completing the DS This information should also be on your I or DS form. Can my answers be in my native language? Applications submitted in any language other than English will be denied, and you may be required to submit a new application. While you must answer all questions in English, translations of questions are available in many languages from the drop-down menu in the right upper corner of the application. These translations should assist you in completing the form in English. Are all questions on the DS mandatory? Most questions are mandatory and must be answered in the spaces provided. If you do not complete a mandatory question, the system will display an error message and require you to answer the question before continuing with the application. Are additional forms required? What happens to my DS if I select a U. Embassy or Consulate where I will be applying for my visa, but end up making an interview appointment instead at another U. The Embassy or Consulate at which you actually apply should be able to access your form using the barcode on your DS confirmation page, which you must bring to the visa interview. For example, a business traveler intends to apply for his visa at the U. Embassy in City X, so he selects City X as the location where he will submit his application when he completes his DS He then has an urgent reason to travel to City Y on business. Because there is a U. Consulate in City Y, he schedules an appointment for a visa interview there, using the barcode from his completed DS application for appointment scheduling. Unless you are exempted from appearing in person, your fingerprints will be electronically scanned on the day of your interview. By providing your fingerprints, you will again certify that that you have answered all questions on the DS truthfully and to the best of your knowledge, and that you will tell the truth during your visa interview. You will be directed to read the following statement prior to having your fingerprints scanned: Furthermore, I certify under penalty of perjury that I will tell the truth during my interview and that all statements made by me during my interview will be complete to the best of my ability. Who is exempt from signing the form? If an applicant is illiterate or unable to complete the application, the applicant must be assisted by a third party. If the applicant has no parent or legal guardian, then the application may be completed by any person having legal custody of, or a legitimate interest in, the applicant.
