

Chapter 1 : Online Application for New NRI PAN Card-ApplyPANIndia

Chapter 2 : ePan Card - Form 49A Application for NRI PAN from abroad countries

You can complete your pending application form or regenerate the acknowledgement receipt by login into the Register user module.

Some of the reasons that would necessitate getting a duplicate Permanent Account Number card include losing your PAN card or your old PAN card incurring damage such that it gets out of shape and becomes unreadable. Your old PAN card could also get stolen and thereby requiring you to get a replacement. The application for getting a duplicate PAN card online is fast and easy. The following is the step-by-step process. The web address is <https://www.incometax.gov.in>: Once the website has loaded you can kick off the process of applying for a duplicate PAN card. On the website you will find several tabs all linking to different services. Ensure you key in the correct details because all the information needs to be accurate. After you have done so you can then click to submit the information. After you have submitted the information an acknowledgement will be displayed. The acknowledgement will bear a unique number consisting of 15 digits. This is an important number which should be preserved. Go ahead and print the acknowledgement card for the sake of reference in the future. You can also save the acknowledgement as a soft copy if you so wish. After getting the acknowledgement you will then be required to send it to the Income Tax Department. Alongside the acknowledgement form several other documents such as proof of identity and proof of residence will require to be attached. Two full colour photos must also be affixed on the acknowledgement form. These photos must be recent and must have a clear appearance as one of them will feature on the PAN card. If you are within India you will need to pay 96 rupees and if outside India. If within India you can pay by credit card, debit card, cheque, internet banking or demand draft. If outside India the payment can only be made by demand draft. The acknowledgement form alongside the attached documents must be sent to Pune before 15 days are over since the application was made. Chapter 6 : Duplicate PAN Card "Pancard"

Payment for Application of Duplicate PAN Card You are required to make payment through demand draft, debit/ credit card after completing the form. If communication address is within India, the fee for processing PAN Application is INR (INR 93 + 18% Goods and Service Tax).

Chapter 7 : Pan Card for NRI and OCI - Online Application from Foreign Countries

PAN Card can be obtained by submitting the PAN application along with required documents (two recent passport size color photographs, Proof of identity, proof of address, date of birth proof along with fees) to the authorized PAN agency of the district or by making online submission of form through NSDL or UTI portal.
