The Masons and the Building of Washington, D.C. David Ovason. Review by Ed King Masons designed Washington, DC! Websites trumpet this news in huge red letters on a black forbidding background.

What we will be seeing in our minds eye comes from the book *Rediscovering God in America*: We will begin with the U. No other building in Washington defines the skyline like this one does. It has been the place of formal inaugurations as well as informal and spontaneous events, such as when two hundred members of Congress gathered on the steps on September 12, 1793, to sing God Bless America. President George Washington laid the cornerstone for the Capitol in 1793. When the north wing was finished in 1800, Congress was able to move in. Construction began again in 1800 under the direction of Benjamin Latrobe. The British invasion of Washington in 1814 resulted in the partial destruction of the Capitol. In 1825, Charles Bulfinch oversaw the completion of the north and south wings including a chamber for the Supreme Court. President Millard Fillmore chose Thomas Walter to continue the Capitols construction and rehabilitation. Construction halted during the first part of the Civil War, and it wasnt until 1863 that the canopy fresco in the Rotunda was completed. The religious imagery in the Rotunda is significant. Eight different historical paintings are on display. The first is the painting *The Landing of Columbus* that depicts the arrival on the shores of America. Second is *The Embarkation of the Pilgrims* that shows the Pilgrims observing a day of prayer and fasting led by William Brewster. Third is the painting *Discovery of the Mississippi by DeSoto*. Next to DeSoto is a monk who prays as a crucifix is placed in the ground. Finally, there is the painting *Baptism of Pocahontas*. Throughout the Capitol Building, there are references to God and faith. In the Cox Corridor a line from *America the Beautiful* is carved in the wall: God shed His grace on thee, and crown thy good with brotherhood, from sea to shining sea! Also in the House chamber, above the Gallery door, stands a marble relief of Moses, the greatest of the twenty-three law-givers and the only one full-faced. At the east entrance to the Senate chamber are the words *Annuit Coeptis* which is Latin for God has favored our undertakings. The words *In God We Trust* are also written over the southern entrance. Also, a prayer is inscribed in the window which says, *Preserve me, God, for in Thee do I put my trust*. From the base of the monument to its aluminum capstone are numerous references to God. This is fitting since George Washington was a religious man. When he took the oath of office on April 30, 1789, he asked that the Bible be opened to Deuteronomy 10:17. After the oath, Washington added, *So help me God* and bent forward and kissed the Bible before him. Mark Twain said it had the forlorn appearance of a hollow, oversized chimney. In 1886, Congress appropriated money for the completion of the monument which took place in 1886. In a ceremony on December 6, 1886, the aluminum capstone was placed atop the monument. Along with it are copies of the Declaration of Independence and the U. If you walk inside the monument you will see a memorial plaque from the Free Press Methodist-Episcopal Church. On the twelfth landing you will see a prayer offered by the city of Baltimore. On the twentieth landing you will see a memorial offered by Chinese Christians. There is also a presentation made by Sunday school children from New York and Philadelphia on the twenty-fourth landing. The monument is full of carved tribute blocks that say: *Holiness to the Lord; Search the Scriptures; The memory of the just is blessed; May Heaven to this union continue its beneficence; In God We Trust; and Train up a child in the way he should go, and when he is old, he will not depart from it*. So what was George Washingtons faith? Historians have long debated the extent of his faith. But Michael Novak points out that Washingtons own step-granddaughter, Nelly Custis, thought his words and actions were so plain and obvious that she could not understand how anybody failed to see that he had always lived as a serious Christian. And they recited Psalm 35 together as patriots. George Washington also proclaimed the first national day of thanksgiving in the United States. In 1789 he said, *When we review the calamities which afflict so many other nations, the present condition of the United States affords much matter of consolation and satisfaction. He therefore called for a day of public thanksgiving and prayer. He said, In such a state of things it is in an especial manner our duty as people, with devout reverence and affectionate gratitude, to acknowledge our many and great obligations to Almighty God and implore Him to continue and confirm the blessings we experience*. Finally, Congress allocated funds for it during the Taft administration. Architect Henry Bacon

wanted to model it after the Greek Parthenon, and work on it was completed in 1887. Bacon chose the Greek Doric columns in part to symbolize Lincoln's fight to preserve democracy during the Civil War. Daniel Chester French sculpted the statue of Abraham Lincoln to show his compassionate nature and his resolve in preserving the Union. One of Lincoln's hands is tightly clenched to show his determination while the other hand is open and relaxed to show his compassion. Lincoln's speeches are displayed within the memorial. On the left side is the Gettysburg Address only words long. He said, We here highly resolved that these dead shall not have died in vain, that this nation, under God, shall have a new birth of freedom. On the right side is Lincoln's second inaugural address only words long. It mentions God fourteen times and quotes the Bible twice. He reflected on the fact that the Civil War was not controlled by man, but by God. He noted that each side looked for an easier triumph, and a result less fundamental and astounding. Both read the same Bible, and pray to the same God; and each invokes his aid against the other. He concludes with a lament over the destruction caused by the Civil War, and appeals to charity in healing the wounds of the war. With malice toward none, with charity for all, with firmness in the right as God gives us to see the right, let us strive on to finish the work we are in, to bind up the nations wounds, to care for him who shall have borne the battle and for his widow and his orphan, to do all which may achieve and cherish a just and lasting peace among ourselves and with all nations. It is fitting that one hundred years after Lincoln's second inaugural, his memorial was the place where Reverend Martin Luther King, Jr. An inscription was added to the memorial in that was based upon Isaiah I have a dream that one day every valley shall be exalted, and every hill and mountain shall be made low, the rough places will be made plain, and the crooked places will be made straight and the glory of the Lord shall be revealed and all flesh shall see it together. At a White House dinner during the war, a clergyman gave the benediction and closed with the statement that The Lord is on the Unions side. I am not at all concerned about that, for I know that the Lord is always on the side of the right. But it is my constant anxiety and prayer that I and this nation should be on the Lords side. In 1903, Franklin Delano Roosevelt persuaded Congress to establish a memorial commission to honor Jefferson. After some study the commission decided to honor Pierre L'Enfant's original plan, which called for the placement of five different memorials that would be aligned in a cross-like manner. The original design was modified, and the memorial was officially dedicated in 1823. When you enter the Jefferson Memorial you will find many references to God. A quote that runs around the interior dome says, I have sworn upon the altar of God, eternal hostility against every form of tyranny over the minds of man. On the first panel, you will see the famous passage from the Declaration of Independence: We hold these truths to be self-evident: That all men are created equal, that they are endowed by their Creator with certain unalienable rights, that among these are life, liberty, and the pursuit of happiness. It was passed by the Virginia Assembly in 1776. Almighty God hath created the mind free. All attempts to influence it by temporal punishments or burdens. No man shall be compelled to frequent or support any religious worship or ministry or shall otherwise suffer on account of his religious opinions of belief, but all men shall be free to profess, and by argument to maintain, their opinions in matters of religion. I know but one code of morality for men whether acting singly or collectively. The third panel is taken from Jefferson's Notes on the State of Virginia. God who gave us life gave us liberty. Can the liberties of a nation be secure when we have removed a conviction that these liberties are the gift of God? Indeed I tremble for my country when I reflect that God is just, that His justice cannot sleep forever. Commerce between master and slave is despotism. Nothing is more certainly written in the book of fate than that these people are to be free. The Supreme Court Of the three branches of government, the Supreme Court was the last to get its own building. In fact, it met in the Capitol building for over a hundred years. During that time, it met in many different rooms of the capitol until it finally settled in the Old Senate Chamber in 1800. It was modeled after Greek and Roman architecture in the familiar Corinthian style and dedicated in 1800. It is ironic that the Supreme Court has often issued opinions which have stripped religious displays from the public square when these opinions have been read in a building with many religious displays. And it is ironic that public expressions of faith have been limited when all sessions of the court begin with the Courts Marshal announcing: God save the United States and this honorable court. In a number of cases, the Supreme Court has declared the posting of the Ten Commandments unconstitutional in public school classrooms and in a local courthouse in Kentucky. there are images of Moses with the Ten Commandments. These can be found at the center of the sculpture over the east portico of the Supreme Court building, inside the actual courtroom, and finally, engraved over the chair of the Chief Justice, and on the bronze doors of the Supreme Court itself. He goes on to say that for the last fifty years the Supreme Court has become a permanent constitutional convention in which the whims of five appointed lawyers have rewritten the meaning of the Constitution. Under this new, all-powerful model of the Court, and by extension the trail-breaking Ninth Circuit Court, the Constitution and the law can be redefined by federal judges unchecked by the other two coequal branches of government.

Were that not enough, there were other areas where the author ignored the influence of historical events or used misleading language in order to support his thesis. Two that stood out were with regard to the building of the National Monument. The author places a great deal of emphasis on the alignment of the planets on the day that the monument was finished and the final point of the obelisk laid in place. He acknowledges that the building slowed for a while, but then gets back to the significance of the date that it was finished, and mentions congressional decrees surrounding the date and time as though it was planned specifically with the Masons in Congress and the final architect who also happened to be a Mason. Following that, he immediately launches into the signing of the Declaration of Independence. For while Washington may have been a Mason, he most certainly was not among the signers and to imply otherwise is not just misleading but fundamentally poor historiography. There were some interesting elements regarding symbolism of the laying of corner stones of the buildings and within the decorations and structures of the building themselves. An overview of symbolism and its significance, followed by an incorporation of the symbolism into the city, and nods to those in the city who were members of the fraternity would have made a much more readable, and even credible book than the one I read. This book would have benefited from being half as long with twice as many applicable illustrations. After adopting the Articles of Confederation in York, Pennsylvania, the Congress of the Confederation was formed and convened in Philadelphia from March until June, when a mob of angry soldiers converged upon Independence Hall, demanding payment for their service during the American Revolutionary War. Congress requested that John Dickinson, the Governor of Pennsylvania, call up the militia to defend Congress from attacks by the protesters. In what became known as the Pennsylvania Mutiny of 1783, Dickinson sympathized with the protesters and refused to remove them from Philadelphia. New York City remained home to Congress until July 1783, [4] when the Residence Act was passed to pave the way for a permanent capital. The decision to locate the capital was contentious, but Alexander Hamilton helped broker a compromise in which the federal government would take on war debt incurred during the American Revolutionary War, in exchange for support from northern states for locating the capital along the Potomac River. Capitol, "An Elevation for a Capitol", by James Diamond was one of many submitted in the contest, but not selected. At least ten individuals submitted designs for the Capitol; however the drawings were regarded as crude and amateurish, reflecting the level of architectural skill present in the United States at the time. Thornton was inspired by the east front of the Louvre, as well as the Paris Pantheon for the center portion of the design. Hallet suggested changes to the floor plan, which could be fitted within the exterior design by Thornton. Hallet was dismissed by Secretary Jefferson on November 15, 1792. The Senate and House shared quarters in the north wing until a temporary wooden pavilion was erected on the future site of the House wing which served for a few years for the Representatives to meet in, until the House of Representatives south wing was finally completed in 1800, with a covered wooden temporary walkway connecting the two wings with the Congressional chambers where the future center section with rotunda and dome would eventually be. However, the House of Representatives moved early into their House wing in 1793. Though the Senate wing building was incomplete, the Capitol held its first session of the United States Congress with both chambers in session on November 17, 1793. The National Legislature was moved to Washington prematurely, at the urging of President John Adams, in hopes of securing enough Southern votes in the Electoral College to be re-elected for a second term as President. The first services were conducted in the "hall" of the House in the north wing of the building. In the House moved to temporary quarters in the south wing, called the "Oven", which it vacated in 1796, returning to the north wing for three years. Then, from 1796 to 1800, they were held in the then-House Chamber now called Statuary Hall. According to the U. S. Capitol Building, "It is no exaggeration to say that on Sundays in Washington during the administrations of Thomas Jefferson and of James Madison the state became the church. Within a year of his inauguration, Jefferson began attending church services in the chamber of the House of Representatives. Worship services in the House were a practice that continued until after the Civil War were acceptable to Jefferson because they were nondiscriminatory and voluntary. Preachers of every Protestant denomination appeared. Catholic priests began officiating in 1802. As early as January a female evangelist, Dorothy Ripley, delivered a camp meeting-style exhortation in the House to Jefferson, Vice President Aaron Burr, and a "crowded audience". George Bomford and Joseph Gardner Swift, both military engineers, were called upon to help rebuild the Capitol. Reconstruction began in 1800 and included redesigned chambers for both Senate and House wings now sides, which were completed by 1807. During the reconstruction, Congress met in the Old Brick Capitol, a temporary structure financed by local investors. Construction continued through 1815, with the addition of the center section with front steps and columned portico and an interior Rotunda, rising above the first low dome of the Capitol. Latrobe is principally connected with the original construction and many innovative interior features; his successor, Bulfinch, also played a major role, such as the design of the first low dome covered in copper. The new underground facility provides a grand entrance hall, a visitors theater, room for exhibits, and dining and restroom facilities, in addition to space for building necessities such as an underground service tunnel. A large-scale Capitol dome restoration project, the first extensive such work since 1850, began in 1982, with completion scheduled before the presidential inauguration. The House wanted to spend less on government operations, [37] but in late 1982, it was announced that renovations would take place over two years, starting in spring 1983. The winning bidder was an Israeli company called Foxcom which has since changed its name and been acquired by Corning Incorporated.
