Posts 1, Wow, another board member, catsmeow thanks!! First of all, a short acting med like you were getting, the Hydrocodone 5mgs and Acetaminophen mgs is not a long-term pain control med, which is exactly the problem you were having with it. These typically take as long as 20 minutes to start working and they only last about 4 hours, more or less, depending on your pain level and how bad or out of control it is. For total pain management, these types of meds should only be used as a med for breakthrough pain, that way it works fast and last while, until the long-acting med you should be taking can kick in. The correct dosage of these, either for short term control of bad pain from say an auto accident injury, broken bone, or as a breakthrough med should be every 6 hours, and it can be taken, if needed and doctor approved, as often as every 4 hours for those with serious pain issues. My husband was in intensive case management for a few years after he left from being hospitalized for depression, and I know she would and was able to go to bat for anything he needed her to handle, that is what these people are there for. Obviously this doctor has an ego problem, a god-complex it seems, and has trouble with anyone questioning his authority. The fact that he would not even talk to you about your problems with the med not handling your pain is a dead give-away that he is a know-it-all who thinks he knows all there is to know about it, and that he even thinks he knows you, your body, and your pain levels better than you do. What a ridiculous attitude. If you did, make sure you keep your therapist updated on how he treated you and why he claimed he wanted to see those records, if you also explain that you signed them under duress because of his anger and feeling threatened, they may cancel his order to get copies of them, or if they have already sent them, they can prevent him from getting any future information that you do not authorize. As to firing him, yes, you have every right to do that and to go see a different doctor, if you have a family doctor, or talk to your therapist, or case manager, they might be able to find you a better doctor nearby that can help you and provide you with a referral for treatment. You are never obligated to continue treatment from any doctor that you feel is volatile, not listening to his patients, and who is not adequately meeting your needs. So just like a doctor is not ever obligated to treat you, except for when you are rushed to an emergency facility with a life-threatening condition, neither are patients obligated to continue under any doctor that they are not happy with for whatever reason. Now, as to reporting his behavior YES make sure that you do. When he starts losing business and wondering why, maybe he will learn something. This "doctor" and I am using that term very loosely at the moment! I am really sorry if this upsets you further, but you really need to know this so you can protect yourself, but he could be putting notes in there saying you are a drug addict, or you are showing drug seeking behavior and etc. It sure seems like he assumes that everyone using his service is an addict instead of a pain management patient, and if he has that listed in your records from his office, it could create real problems for you in the future when you try to see a different pain specialist or need additional treatment. More than anything else in your file, other doctors rely on the information put in there by your treating doctors to get a true assessment of you. It is just the way things work in the medical community. So even if you got a copy and they look fine, you have no way of knowing what he is sending to or telling other doctors about you. So, the smartest thing to do would be to have your family doctor request copies of his records, one you have apprised them of the situation, or to have your therapist obtain them. That way you can sit with them and look through and check what he is putting in there. Now, another way to protect yourself, do not be shy about inviting any new doctor you see for treatment to check you out as thoroughly as they want, be honest with them, let them feel comfortable treating you. A few minutes is all it will take for them to have your name punched up in the DEA database, which records all pharmaceutical transactions and see that you were not trying to abuse meds, or do doctor or pharmacy hopping. Even if this is something you did in the past, by being honest and open now, you can prevent them from being worried that you are still doing it. But

seriously, this doctor is acting like he is treating a bunch of addicts, and not people with real medical problems. I mean if he is that miserable doing pain management and not really helping anyone, there is nothing making him stay in that speciality. I really feel sorry for what you are going through here, and I totally sympathize. This advice is not coming from just another board member, I am a chronic pain patient myself, an am disabled due to a degenerative spinal condition. No matter what I take med wise, I am in pain everyday, all day, due to a nerve root impingement of my sacral nerve. Anyway, sorry my post is so long winded, I just wanted to explain some things, and let you know that you are not alone in having bogus pain management problems. Most doctors are great and really care about helping people, but there are those bad apples that get greedy and just want to get whatever money they can out of you or your insurance, and they could care less what happens to you, or if you are really in pain and need help. Very sad, but true nonetheless. If you do a search online, you will find other people with similar experiences and it is very, very sad and tragic. It scares some people away from getting the help they need, and because of the people who have abused meds, and played the game of doctor and pharmacy hopping, all docs must now be cautious and wary when they treat someone in pain and they have to make sure you really do need these pills and be ready to explain that to the DEA at any time if they give you that prescription. Every month when I go in now for my med review appointment, I watch as she has to Xerox copies of the scrips she gives me, so they have them all on file if they need them. You will even find some posts on here, from quite a few people, who through no fault or abuse of their own, ended up being reported as participating in suspicious behavior and being red-flagged to all docs, hospitals, and pharmacies by the DEA. It is a nightmare for them to get it straightened out again so they can get the treatment they desperately need and deserve. Sometimes they just shared a name with someone else, sometimes they had prescriptions stolen or they accidentally ran out a little earlier than the DEA thought they should because their pain was out of control and they had to get by until their next docs appointment, so all the rest of us have to suffer because of the abusers. Your new doc might want you try to same med for awhile, either on a higher dosage since the Hydro pills are available in up to 10mgs or at a more frequent daily dosing schedule of the same dose, because they will want to try to use something as mild as possible to get your pain under control, before resorting to the heavier and stronger meds. You are also going to have to make sure you give any med or therapy they try a fair chance to work, before going in and saying you need something stronger. But, unfortunately, just like I said before, chronic pain patients with real, legitimate medical problems do have to suffer because of the abusers and the measures that the DEA, docs, and pharmacies have had to take to try to prevent that. However, if you get a good doc this time, who is really educated about pain and managing it, it will not take very long to establish yourself as being fully cooperative and reliable, and they will eventually relax with you and be willing to work with you to get you a med that works. See there are also many people out there who expect a miracle when they finally get a narcotic prescription for their pain, they expect that drug to work immediately and get rid of all their pain, so they can feel normal again. When you first start taking it, you will more than likely get some relief, but you do have to keep using it for a few weeks until you get the full benefit of the drug and the worst of the side effects wear off. I eventually lucked out as a doctor who has taken courses in pain management and is now a specialist in it, joined my doctors practice, so I no longer have to run out trying to figure out who can help me, he is right there ready to advise and sign scrips everytime I go in for my monthly appointment. The complaint was that Gosnell had been unable to complete an abortion, but then apparently failed or refused to call paramedics or other clinical emergency personnel, after the patient had needed help. The patient reported, "I really felt like he was going to let me die. The investigation had also revealed the suspicious death of patient Karnamaya Mongar in , which had in turn brought to light further information about unsanitary operations, use of untrained staff, and use of powerful drugs without proper medical supervision and control. Thus, when the February raid took place, staff from the Pennsylvania Department of State and Pennsylvania Department of Health also attended, as these issues were under their remit: There was blood on the floor. A stench of urine filled the air. A flea-infested cat was wandering through the facility, and there were cat feces on the stairs. Semi-conscious women scheduled for abortions were moaning in the waiting room or the recovery room, where they sat on dirty recliners covered with blood-stained blankets. All the women had been sedated by unlicensed staff " long before Gosnell arrived at the clinic " and staff members could not accurately state what medications or dosages they had administered to the waiting patients. Equipment was rusty and outdated. Oxygen equipment was covered with dust, and had not been inspected. The same corroded suction tubing used for abortions was the only tubing available for oral airways if assistance for breathing was needed" [33] [F]etal remains [were] haphazardly stored throughout the clinic" in bags, milk jugs, orange juice cartons, and even in cat-food containers Gosnell admitted to Detective Wood that at least 10 to 20 percent In some instances, surgical incisions had been made at the base of the fetal skulls. The investigators found a row of jars containing just the severed feet of fetuses. In the basement, they discovered medical waste piled high. The intact week fetus delivered by Mrs. Mongar three months earlier was in a freezer. In all, the remains of 45 fetuses were recovered Public discussion focused on claims of unsanitary conditions and other unacceptable conditions at the practices. Media reports stated that furniture and blankets were stained with blood, freely roaming cats defecated wherever they pleased, and that non-sterilized equipment was used and reused on patients. Once labor began, the patient would be placed on a toilet. After the fetus fell into the toilet, it would be fished out, so as not to clog the plumbing. In the recovery room, patients were seated on dirty recliners covered in blood-stained blankets. He was charged with eight counts of murder. Steven Massof, a clinic employee who pleaded guilty to similar charges in , testified that he Massof had snipped the spines of more than infants after they had been born alive, and that this was considered "standard procedure" at the clinic; a number of other employees had also testified to the same point. Patient described the pain four days after abortion as being so bad she could barely walk. The patient described that upon returning to the clinic because of the pain, ultrasound showed fetal remains left inside her uterus, and that Gosnell suctioned these out without anesthesia.

Instead, the patients had to fill out a daunting five-page form, available only in English, that required them to reveal their identities upfront and be available to testify in Harrisburg. Even with CHOICE staffers there to help, only two women agreed to fill out the form, and both decided not to submit it. The Department of State and the Philadelphia Public Health Department also had ample warning of dire conditions and took no action. It stated that, while some might see the issue and case through the lens of pro- and anti-abortion politics, it was in reality: We find common ground in exposing what happened here, and in recommending measures to prevent anything like this from ever happening again. Most of these were deemed infeasible to prosecute because files and other evidence were not held, although the report stipulates they numbered in the "hundreds". The charges recommended were: The jury also recommended charges of solicitation to commit murder by Gosnell. Her death was the direct result of deliberate and dangerous conduct by Gosnell and his staff. Of Gosnell himself, the report concluded, We believe, given the manner in which Gosnell operated, that he killed the vast majority of babies that he aborted after 24 weeks. We cannot, however, recommend murder charges for all of these cases. In order to constitute murder, the act must involve a baby who was born alive. Because files were falsified or removed from the facility and possibly destroyed, we cannot substantiate all of the individual cases in which charges might otherwise have resulted. She eventually rose to become director of the division that was supposed to regulate abortion providers, but never looked at Gosnell despite specific complaints from lawyers, a doctor, and a medical examiner. After she was nonetheless promoted, her successor as division director, Cynthia Boyne, failed to order an investigation of the clinic even when Karnamaya Mongar died there. Senior legal counsel Kenneth Brody insisted that the department had no legal obligation to monitor abortion clinics, even though it exercised such a duty until the Ridge administration, and exercised it again as soon as Gosnell became big news. Lawyers at the Pennsylvania Department of State behaved in the same fashion. Attorneys Mark Greenwald, Charles Hartwell, David Grubb, Andrew Kramer, William Newport, Juan Ruiz, and Kerry Maloney were confronted with a growing pile of disquieting facts about Gosnell, including a detailed, inside account from a former employee Marcella Choung, [85] , and a year-old dead woman. Every time, though, they managed to dismiss the evidence as immaterial Recommendations[edit] The Department of Health should explicitly regulate and annually inspect abortion practices, and examine patient files, licenses, and equipment on-site; Second-trimester abortions should be performed or supervised by doctors who are board-certified obstetrics and gynecology; The Department of State "must repair its review process", including easier reporting, confidentiality, post-investigation response, with cases automatically checked against past records, malpractice databases, and full past history; Reports about individual doctors checked against reports of medical offices where they worked, and vice versa; The Department of Public Health "should do at least as much to control infectious medical waste as it does to inspect swimming pools"; The conclusions finished by examining the extent to which legislation had been inadequate, and the scope for legislative change, concluding that: Infanticide and third-trimester abortion are serious crimes. period for late abortion should be extended to five years; infanticide, like homicide, should have none. Impersonating a physician is also a serious, and potentially very dangerous, act. Yet under current law it is not a crime at all. An appropriate criminal provision should be enacted. There may also be other statutory and regulatory revisions that we, as lay people, have not thought to consider. Legislative hearings may be appropriate to further examine these issues. Another employee testified that she assisted with late-term abortions "on Sundays or days we were closed [to] do special cases. Media sources following the trial have suggested that there may have been insufficient evidence of post-procedure life to sustain charges in law. Although prosecutors had argued the movements were voluntary and therefore signs of life, [96] [97] it was argued that the evidence offered by prosecutors were equally capable of being interpreted in some or all of these as single autonomous post-mortem motor movements or spasms instead of clinical signs of life, and additionally that none of the seven were capable of being alive as all had been previously killed clinically in utero by means of drugs as part of the procedure. The 3rd-degree murder charges in the death of Karnamaya Mongar, the racketeering charge, and over charges related to multiple violations of abortion law were also left standing. Steven Massof, a medical school graduate who lacked a license, pleaded guilty in November to two counts of 3rd-degree murder for the deaths of two babies who had been born alive. She pleaded guilty to these charges on Dec. Gosnell presented these employees as physicians and billed insurance companies more on this allegation. All three are charged with theft by deception for these acts. He was found not guilty on one of the counts of murder. In exchange, prosecutors allowed Gosnell to be sentenced to life in prison without the possibility of parole. The only case for which any reports were produced was that of Semika Shaw, a year-old, who died at the University of Pennsylvania hospital as a result of bleeding and sepsis caused by a botched procedure by Gosnell. All remaining felony charges, including those against Maricel, were dropped. Fullerton maintains he did nothing wrong and only took the deal to make the rest of the charges go away. It was far from the end of their troubles, though. Despite the charges against Maricel Fullerton being dropped, the case also impacted her career as a vocational nurse.
